

KIWI DANCING SWEEPSTAKES

OFFICIAL RULES

No Purchase Necessary to Enter or Win.
Void In Puerto Rico, Canada and where prohibited

All entries have an equal chance of winning.

1. **Eligibility:** The *Kiwi Dancing Sweepstakes* (the “Sweepstakes”) is open only to legal residents (natural persons only) of the 50 United States or the District of Columbia who are 18 years of age or older as of 3/15/2010, except employees, officers and directors of Sara Lee Corporation (Household & Body Care USA division) (“Sponsor”), Vault Communications, Inc., ABC and ABC Dancing with the Stars show producers and each of their respective parent companies, affiliates, distributors, subsidiaries, retailers, and advertising/promotion agencies (collectively, “Released Parties”) and the immediate family (spouses, parents, children, and siblings and their respective spouses) and household members of such individuals.)  - (a) **Online:** To enter the Sweepstakes without purchase and receive one entry, visit www.kiwidancingsweepstakes.com and click on the promotion “button” on the Home Page. Once at the entry page, follow the instructions and fully complete and submit the online entry form according to the instructions provided during the Promotion Period for an entry to the Sweepstakes. You must confirm that you have read and agree with these Official Rules. **Limit one (1) online entry per person, regardless of the number of e-mail addresses used, during each day of the Promotion Period as the case may be (with a day defined as the 24-hour period beginning at 12:00:01AM ET and ending at 11:59:59PM ET). Additional entries received from any person or e-mail address during any one day of the Promotion Period will be void.** Entry will be awarded to the person named on the applicable entry form (regardless of whether that is the name of the authorized account holder of the e-mail address from which said entry form was submitted). The use of automated entry devices is prohibited.
 - (b) Your submission of an online entry constitutes your consent to participate in the Sweepstakes and your consent for Sponsor to obtain, use and transfer your name, address and other information for the purpose of administering the Sweepstakes. Released Parties are not responsible for any error, omission, interruption, defect or delay in transmission or communication; theft, destruction or unauthorized access to, or alteration of, entries; 3rd party transaction classification, transaction processing, or communication; technical or mechanical malfunctions; failures or malfunctions of phones, phone lines, or telephone systems; interrupted or unavailable network, server or other connections; traffic congestion on the Internet or any technical problem, including but not limited to any injury or damage to entrant's or any other person's computer related to or resulting from Sweepstakes participation; errors or omissions in these Official Rules, in any Sweepstakes-related advertisements or other materials; human-processing error; failures of electronic equipment, computer hardware or software; or inaccurate entry information, whether caused by equipment, programming used in the Sweepstakes, human error, or otherwise. Odds of winning Sweepstakes depend upon the number of entries received. ("ARV" of all prizes=\$9,000)

4. Potential Winner Selection – Taxes: Potential winners of the Sweepstakes will be selected in a random drawing on or about 9/10/2010 from among all eligible entries by Sponsor, whose decisions will be final and binding in all matters relating to the Sweepstakes. Potential winners of the Sweepstakes will be notified by 9/15/2010 by telephone and/or mail. Potential winners must meet all eligibility requirements, indicate to Sponsor their ability to attend the Lesson on the date selected by Sponsor, and submit required releases as stated in these Official Rules to become verified winners. Odds of winning will depend on the number of eligible entries received. Limit (1) prize per person, immediate family, or household. Verified prize winner will be responsible for all taxes (including but not limited to federal, state, local and/or income) on the prize and will be required to provide his/her Social Security number for tax reporting purposes if the retail value of the prize being awarded is \$600.00 or greater (as determined in Sponsor's sole discretion).
